CIRCULAR LETTER #612 POST-MEETING FALL DECEMBER 2009

The New Year is upon us and it seems appropriate to reflect back and look forward to 2010. Like the rest of the world, 2009 was a challenging one for GAP financially, but we survived! A number of factors helped us get through it which warrant acknowledgement. First, thanks to all our members who did not request travel reimbursement to attend the meeting. It is an added financial burden to come to New York from out of the great metro area and the Board and I are very appreciative of your generosity. We give special thanks to Mike Skoien and Shire Pharmaceuticals for a grant to support the GAP Fellowship and to the Cotswold Foundation for an unrestricted grant. The Finance Committee will discuss the most effective use of this gift at the Spring Meeting from the Cotswold Foundation and hope they will attend the Spring Meeting. These three activities allowed us to right our financial ship for 2009 and 2010 and maintain an appropriate reserve fund moving forward. As Steve said in his Treasurer's report, "We are moving back from the cliff" and have a sound financial plan for our immediate future. Running a fiscally responsible, might I say lean and mean, organization has served us all well – thanks Frances! A point of clarification is warranted. A member approached me after the announcement of the Shire gift was made at our Fall meeting. The member was very upset and expressed concern that we had acted immorally by accepting the gift and were not in compliance with APA standards on conflict of interest. I appreciate the concern over GAP's reputation, but want to clarify the point. There is no conflict of interest. GAP does not conduct research with Shire, we offer (nor were requested) a presence at our meeting, and we do not write treatment guidelines which might be perceived as biased. Shire has asked for nothing in return for their gift to help support our Fellowship program. We have an existing policy of accepting similar donations from Dear Abby and other philanthropic organizations. I have discussed this matter with colleagues on the APA Ethic's Committee who agree with our position. We also make full disclosure of our financial matters. The entire conflict of interest topic seems worthy of a GAP paper or op-ed piece, given its ongoing political valence. Despite our delicate financial balance, GAP is not for sale and will remain an independent psychiatric think tank. This is my New Years resolution as your president.





Publications Board:

1. Update on approved Reports:

- a. The Psychopathology Committee manuscript, "Implementing Standardized Assessments in Clinical Care" was published in the October 2009 Psychiatric Services.
- b. The Cultural Committee editorial, "Issues for DSM-V: Role and Relevance of Culture in Psychiatric Diagnosis" was published as an editorial in Journal of Nervous and Mental Diseases, 2009.
- c. The Psychotherapy Committee book on Psychotherapy was published by APPI, 2009.
- d. The Gender and Mental Health Committee had its article, "The Myth of the Abortion Trauma Syndrome." published in the Harvard Review, 2009.
- e. The Psychopathology Committee manuscript "Rational Protection of Subjects in Research and Quality Improvement Activities" will be published in Psychiatric Services February 2010.
- f. The Psychiatry and Community's editorial, "Jailing is failing People with Mental Illness" appeared in Psychiatric Services, 2009.
- g. The Psychopharmacology Committee's report on OTC appeared in Primary Psychiatry, 2009.

2. New approval procedure for the format of Op Ed pieces.

- a. While occasionally in the past Committee's have written Op Ed pieces it has been difficult to have them approved quickly enough to respond to events as they are happening. With the help of the LGBT Committee who has been working with a publicist, committee's are beginning to write "boiler plate" editorial pieces that can be pre-approved by the Publications Board. Four such Op Ed pieces were reviewed by the Publication Boards: 3 from the LGBT Committee and 1 from Work and Organizations. Three were

approved as GAP products though ultimately two newspapers decided there was not space or that they did not want to use a committee of GAP but only an individual contributor's name. A third is awaiting review by the NY Times. The fourth was a personal piece deemed by the Chair of the Publications Board and President of GAP as best to be submitted as an individual contribution.

- b. Because these Op Ed pieces may take more of a political position the following process has been put in place for review: The Publications Board has been delegated the task and responsibility to decide both on content and GAP representation. If there is uncertainty regarding the particular views in the Op Ed piece, the Chair of the Publications Board and the Executive Committee of GAP will make the final determination of whether the piece should be approved as a GAP product or whether it should be an individual contribution by members without the GAP imprimatur. In any case, should there be a request for immediate turn around the Publications Board will continue its 48 hour feedback to new Op Ed pieces reacting to breaking news with important mental health implications.

Two Strategies for Increasing GAP Committee Productivity

As two relatively new members of GAP, we have been continually amazed at the level of creativity, wisdom, and productivity in our committees and in GAP as a whole. The projects we have and are continuing to work on are both important and stimulating, and the discussions both in committee and in other settings over the two GAP weekends each year have stimulated our thinking and changed our practice, teaching, and writing in positive ways. We return home from GAP a little behind in our e-mail, our household chores, and our clinical obligations, but far ahead in our energy, enthusiasm, and plans for positive accomplishments. There is usually a flurry of activity in the few weeks after each GAP meeting and in the few weeks before as we scurry to complete promised drafts or assignments. The recent suggestion of lengthening the meeting into Sunday on an optional basis has some appeal. However, for those of us who are child psychiatrists with our annual meeting at the end of October, and who may also be giving Child & Adolescent Psychiatry Board Exams in the beginning of November, a longer weekend would be difficult. Two suggestions that may help increase ongoing committee work during the interval between meetings are mid-year committee conference calls and the use of a tool called a "Wiki."

Conference calls have been used by at least one GAP committee to help complete a project on which they were working, and many GAP members have had experience using them in other organizations. Those in academic settings may be able to organize conference calls through their university. If not, there are a variety of organizations that can provide them. There is the possibility of GAP developing a contract with a company that would then provide the conference call support for GAP committees. When using a conference call to carry out committee work, it is helpful to have a clear agenda e-mailed out to members before the meeting.

A second strategy is to use a tool called a "Wiki." A wiki is a combination of a web page and a word document and is specifically designed to facilitate team productivity and collaboration. By locating the saved document on the Web, one doesn't have to send a new version to committee members each time a document is revised. When collaborators go to the webpage to look at the article, what they see is the most current version. At the same time, all previous versions of the article are saved, so one can easily find and correct changes that are later decided not improve the article. You can use a wiki without knowing about it, but for those who wish to understand more about the technology, practicalities, and potential uses of Wikis, we encourage you to get a copy of *Wikipatterns* by Stewart Mader. The best known wiki is Wikipedia, BUT if you don't like Wikipedia it is important to remember that a wiki is a tool, and tools are not responsible for what people use them to build. The atom bomb shouldn't be blamed on wrenches or blackboards even though both were important in its construction. A wiki can be used to keep committees informed about the latest document a member is writing without a constant barrage of e-mails each time the article is expanded or changed, and the problems associated with collaborators working independently and later attempting to collate changes. The original author of the article can decide who is allowed to edit the article, and who can look at it and send comments but not revise it. Early in the process a principle author may want input from several or all committee members, but as the final draft approaches, it may be better to restrict who can make revisions.

The easiest and most accessible Wiki to use is provided by Google. You will need a Gmail account to create a Google Document, and for you and your collaborators to access the online document to read and edit it. As mentioned above, a "wiki" is an online document that can be revised in real time by multiple collaborators.

Go to <http://www.gmail.com> to sign up for a Google email account (Gmail). You will not have to switch email providers. This is simply a mechanism to have access to this service. I never receive junk mail on my Gmail

account. I personally use that account for special situations, e.g., travel to GAP meetings, as I prefer to limit my email only to family while away. Once you have a Gmail account, which will be password protected, you will be able to create a Google Document (G-Doc), share it with collaborators, and revise and edit it. It is auto-saved something like every 20 seconds, so it is hard to lose work that has been done. Collaborators are always viewing the most current version, even if editing simultaneously.

To share the document, click in the "Share" menu box on the top right hand side on the title line. Click on the "Invite people" line, then type or paste the e-mail addresses of collaborators you are inviting to work on the document with you. To see who you have already invited, you can click on the "See who has access" line in the same "Share" menu. You can e-mail the article as an attachment to someone who prefers to work offline, or someone whose input you would like, even though they are not a collaborator. You can also send an email message to collaborators when you have made some changes to the document, or if you would like them to comment on a specific section.

In the "File" menu to the far left of the document, the entire Revision History can be seen. This is useful for reviewing and reconsidering changes made by other collaborators. Every change is thus available for reconsideration at any time. Each collaborator can add material, make changes, or add a "comment," using the comment function. Comments are inserted wherever the cursor is placed. Just pull down the "Insert" menu in the blue menu bar to add a "Comment." Comments can be added in different colors to designate a particular person or other attribute. To add comments in color, put the cursor in the comment bar and right click.

We have invited all committee chairs to collaborate on this article, and also all the GAP Fellows (since they are probably more familiar with Google documents and Gmail than the two of us). Others who wish to add or modify this particular document. "Two Strategies . . .," can ask to be added as collaborators by e-mailing Doug Kramer <dakrame1@wisc.edu> or Stu Copans <sacopans2@gmail.com> for access. In that sense, it remains a living document by way of the "wiki" process.

Finally, a word about the process of writing this article - which was done via the Google Document wiki mechanism described herein. GAP is at its heart a networking, collaborative, cooperative, interactive, creative, regenerative mental process. This idea began as current GAP Fellow, Frederick Langheim, M.D., mentioned the possibility to one of us in an airport on the way home in April 2009. I asked him for more detail, laptop in hand, at the Noon meal, at the beginning of the November 2009 meeting. I then mentioned the idea to my GAP roommate, the other of us, on our annual Friday afternoon stroll before the 2:00 PM session. We started playing with it that evening after all of the normal GAP activities had ended for the night. We did so in our room, using one computer, but logged into two email accounts, beginning with the establishing of a Gmail account for one of us, and proceeding as described above with multiple additional dead ends, and by about 12:30 AM had it mastered, using the word liberally, enough to suggest it to our respective committees on Saturday morning. At least two GAP articles are currently being written using this method. Younger members would likely have accomplished more in 15 minutes than we did in a few hours, but probably not with quite the satisfaction that we experienced.
